The motion carried unanimously.

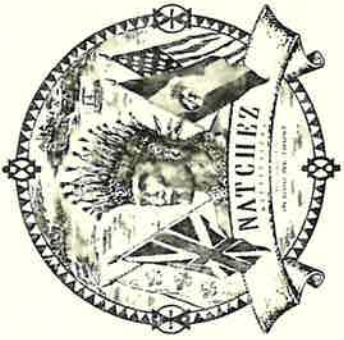
